00:38:30 Laurel: They issued me ear tags with my Premise ID only. So you are saying I have to have both for microchip but not for ear tags? Sorry, don't understand as the microchip purchase website says Premise and/or Flock #. Confused.  
00:38:50 Sister Mary Elizabeth Garrett: Registry rule in National Scrapie Standards states:

For registered animals:

- The electronic implant number has been recorded in the book of record of a sheep or goat registry association and on the registration certificate; and
- The animal is accompanied by a copy of the registration certificate and, if not in the name of the current owner, a copy of the completed application for transfer of ownership in the name of the current owner where the sale occurred within 60 days, or for animals under 60 days of age, a copy of a completed application for registration.

As I read this, a copy of registration must accompany animal at time of sale with transfer made to new owner within 60 days. Is this a correct reading of this?

00:47:06 Laurel:when you have an ear tag, a registration form is not required.

00:47:20 Clover Brooke Farm- Hyde Park, NY: The Llama and Alpaca communities have been using microchips for years. Their are general chip scanners that most fairs/festival and Vet Office use for identification. Our registration papers and CVIs always list the microchip number

00:53:18 Laurel:Is it correct that if you use a microchip, for crossing state lines, that you must have the animal registered? Whereas, I know this is true - that if you use an ear tag, no registration certificate is required and I have seen this stated on the APHIS website.
