5. Research Project

Danielle received information from Terry who shared that they have received 150 samples already. Others are on their way to be ship. Terry will process them in batches of 96 before they have sent them to Texas A&M for further testing. Reminders have been sent to membership via email and social media.

6. Judging Clinic Call to Action

Christine will be sending a confirmed the committee. Consultants can be brought on as needed for specific areas. Joe David will be attending along with Jayne Dearoff, Wendy Pieh, Christine McBrearty, and Ruth Hawkins. The first meeting will be in June.

7. Show Committee

Danielle shared that her 4-H group took advantage of the youth CGA sponsorship program. Hoofprints will also share this information. Wendy will be at Estes Park in June and will send them the CGA youth organization sponsorship scholarship information.

8. CGA Educational Initiatives

Two educational webinars occurred last month. Parasite 101, which had 100 plus participants and Langston's nutritional calculator presentation that was just shy of 40 participants. All programs are posted on the CGA YouTube channel that now has over 100 subscribers. A potential upcoming program discussed by Danielle was the topic of foraging for goats using

the Pearson Square. This formula can be used for hay/grain ration to feed. Danielle will reach out to set up this presentation.

The Zoom capabilities for over 100 participants would be a significant cost to CGA. (\$1200.00 yr.) Christine and Danielle will be keep an eye on the enrollment number to see if paying for an account is worthwhile for CGA.

David asked if it was something we could off as an expense. Elyse shared that right now since we are not a non-- for profit we can't but it is a valid expense towards education which is goal of CGA.

9. Fundraising

Bella is working on ideas for our new logo that would include such items as stickers and pins, and big tote bags!

10. Social Media

Danielle reported that there has been steady increased in engagement numbers. *Ply Magazine* is conducting a cashmere project competition with finished products due in September. CGA should keep an eye out in order to inform our members for how goat fibers are being utilized.

Elyse inquired as to if CGA can conduct their own contest regarding cashmere usage. Maybe three classes knitted, waste, felted project classes that can be displayed at Rhinebeck. Jayne agreed it would be a great educational activity. Elyse shared that inviting a fiber artisan /judge would bring in a broader audience. Danielle will brainstorm class divisions. Elyse recommended a small committee to develop this idea further.

There is presently a live show superintendent opening. Loriann Fell volunteered to work as a partner with another person to help with a show. Christine will send Loriann Sister Mary Elizabeth's information to collaborate on a future show. Elyse also volunteered to assist Loriann.
