

## **December 15th 2024 CGA Board Minutes**

*Elyse discussed the idea of a cell phone reminder for future meetings!*

### **1. Approval of the November 2024 Meeting Minutes**

Dorothy motioned to approve the minutes; Cody seconded.

### **3. Database /Registry- Confirmation standards for the registry**

Nadya shared that for the Boer Goat breed standard there is an "Ennobled status" for conformation with a point system. You can then get a certificate for confirmation.

*"Non-inspected Boer goats can achieve Ennobled status through their progeny, when at least three of these progeny have earned a combined total of one hundred points and those progeny have passed visual inspection, as certified by the ABGA Secretary."*

Danielle shared that dairy goats adhere to a more linear appraisal by a judge on a 1-100point system with letters to associate values.

The idea of an "optional" feature to incorporate confirmation within the CGA registry but not required to enroll, was agreed by the board as a good idea to follow up on. Pam M. reminded the board that confirmation attributes to some degree can be a preference for each farm, however additional certification could be a helpful requirement if taken directly from the scorecard. It could be a great incentive to feature strong bucks available for breeding.

Conformation scores are 0-3 on the scorecard. Judges would need to align how conformation scores are awarded.

Pam Marshall volunteered to help Elyse gather the judges for a future discussion on this topic.

Cody reiterated the importance of the judge's alignment of the basic conformation scoring.

**Next Step:**

- Bringing the judges together
- Create a written document to be communicated on how confirmation will be scored with uniformity amongst judges with the 0-3 scoring.
- Incorporate a system into the database to support this data
