CGA had a table with fiber educational /instructional items such as fiber samples. Dorothy brought five goats with her including a baby bottle! Pam and Dorothy judged the costume contest. Students also participated in a scavenger hunt. Friday and Saturday they participated in a vendor booth. The program had good courses and classes, but the vendor area was lacking. Dorothy gave a PowerPoint presentation on an introduction to cashmere goats. Dorothy will give the coordinator feedback about the vendor space and discuss ideas on how CGA might continue a presence in the fiber space for next year. Pam shared that 50 youth participated in the program. No numbers were available on how many adults attended the classes.
